Topic: Public Financing of Campaigns—Two Points of View

The 2007 Albuquerque City Council election was the first in which candidates could obtain public financing for campaign expenses. Some candidates chose to use the funding; others did not. The speakers will discuss how those decisions are made. Some timely questions which might be addressed are: How well does the Charter Amendment work? What problems or issues arose? Extension of campaign financing at the state level has clear opposition; what are the issues of opposition and support?

Councilor Winter, who represents District 4, is beginning his third term of office and is serving for the fourth time as Council President. He did not choose to use public financing in his 2007 campaign. Councilor O'Malley, who represents District 2, is beginning her second term. She has served as President of the Council and is currently Vice-President. She did participate in public financing for the 2007 campaign.

DRUG POLICY STUDY COMMITTEE

LWV/ABC PROGRAM PLANNING MEETING

The League of Women Voters of Albuquerque and Bernalillo County (LWV/ABC) met on December 1, 2007, to discuss and review our current local and national positions and to hear summaries from committee chairs of their work to date to see if any revisions were needed.

Committee Reports

Advocacy. The steering committee will continue to focus on education and lobbying. Critical local issues identified were health care, housing, land use, transportation, drug policy, and school governance. State and national critical issues identified were campaign finance reform and the election process.

School Governance. Committee work has included establishment of a preliminary work outline and an extensive bibliography. Research will begin to see if there is any connection between the way students perform in school and school governance. The committee is particularly looking at the principal level. The members recommendation was to support continuation of this study.

Drug Policy. The members recommended continuation of the study.

Fair Representation. This two-year state study group is just beginning to look at the growing body of information that will help to understand issues around reapportionment and redistricting in New Mexico and to advocate approaches which will be fairly representative. The group is seeking members, as are the above study groups and committees.

Local Positions

A generic recommendation was made that a committee be established to look at what changes might be needed to the following policy areas at the time of the name change from the LWV/ABC to the LWV of Central New Mexico as this change will include the addition of Sandoval, Torrance and Valencia Counties.

Drug Policy. No recommendations for change.

Education. No recommendations for change.

Health Care. A recommendation was made that 2 or 3 people review the local position to see if there is any conflict with the state or national positions.

Housing. No recommendations for change.

Initiative and Referendum. No recommendations for change.

Local Government. No recommendations for change.

Land Use. No recommendations for change.

Transportation. No recommendations for change.

Water. Recommendation was made to work with the state study group in the process of doing a two-year study, and to update the local position once the state group was completed with their work.

National Positions

A recommendation was made that a brief statement be sent to the League of Women Voters/United States (LWVUS) that the LWV/ABC supports focusing on representative governmental issues over the next two (2) years.

Snapshot of Three State Leagues Pursuing Redistricting Studies LWVNM Fair Representation Committee

Fair Representation and how our government is chosen takes many forms, and the history of partisan gerrymandering—carving out legislative districts with safe seats that protect incumbents and certain districts for each party—is well known. Even the Voting Rights Act has been used to concentrate minority voters into a small number of districts. The investigation of reapportioning legislative districts following the decennial census and who makes those decisions has been taken up by LWV members around the county. Leagues have investigated and lobbied to protect the right to vote. Let's take a look at Washington, Ohio, and Maryland.

Washington: Redistricting by independent commission

The state of Washington is unique because voters do not select a political party in order to register. At the time of primary elections, they use what is termed Open Private Choice where every registered voter may "choose" to cast either a Democratic or a Republican ballot. In 1983, a new law established the state's bipartisan Redistricting Commission. Majority and minority leaders in the Legislature select two Republicans and two Democrats to serve as voting members of the Commission. The four voting commissioners then select a non-voting chairman. Historical and political data from previous elections as well as information regarding precinct boundaries are provided by the Secretary of State. Laws and agency rules regarding redistricting must be followed. The next Commission will be selected in 2011; by law, they will have a staff and budget. The Commission follows the rules of the Public Meetings Act and citizens are able to make comments.

Maryland: Governor leads

In the spring of 2004, following extensive study, LWV Maryland prepared several consensus questions regarding criteria for legislative redistricting. Currently, the Maryland Constitution gives the Governor the authority for redistricting. "Following each decennial census of the United States and after public hearings, the Governor shall prepare a plan setting forth the boundaries of the legislative districts for electing of the members of the Senate and the House of Delegates." The Governor presents the plan to the President of the Senate and the Speaker of the House of Delegates. If the General Assembly has not adopted another redistricting plan by the 45th day of the session, the governor's plan as presented becomes law.

In addition to considerations of altering Maryland's Constitution, LWVMD considered whether the criteria should a) be changed or expanded, b) include who should have authority to draft redistricting plans, and c) given an independent commission, who should have the authority to appoint members to this commission.

Ohio: Legislature decides

Currently in Ohio, the five-member bipartisan Apportionment Board draws boundaries for Ohio house and senate seats. Its members are the Ohio Governor, Auditor, Secretary of State and a member representing each of the two major political parties. Therefore, the political affiliations of the Governor, Auditor and Secretary of State determine which party will be favored in the redistricting process for the Ohio legislature.

In contrast, the lines for U.S. house are drawn by the Ohio legislature. Therefore, the political composition of the Ohio house and senate determine which party will be favored in drawing district lines for U.S. congressional seats.

Last year, the LWV Ohio supported the general structure of the independent Apportionment Board. The League recommended some improvements, such as more public input and more transparency to the process. It also recommended more safeguards to make sure the Board didn't draw "safe seats" for each party. As the debate continues, the League is advocating for the Eight Points for Redistricting Reform, found at:

Salute to Albuquerque? Not this Year.

Members have been asking when the *Salute to Albuquerque* will be held this year. The *Salute*, a fundraising event begun in 1991, first held annually, and then biennially, will not be held in 2008. Following a meeting of former *Salute* volunteers, a recommendation was made to the Board of Directors that something different be done this year to raise money for our Education Fund. What will be done to raise the much-needed money for the Education Fund? We are going to try a three-fold approach. First let us remember that the *Voters' Guide*, the *Who's Who*, and our other educational projects are our gifts to the community. We plan to personally approach businesses and individuals from outside the League to help us with funding, and we have already begun laying the groundwork for this part of our appeal.

Secondly, keeping in mind that most philanthropic contributions are made by individuals who care deeply about a cause, we will approach you, our members. Members have always responded well to the solicitation letter that has appeared as part of the *Voter*. This year our letter will go directly to you, and we may speak to you about a potential gift. Our goal is to increase the level of giving by our membership.

And finally, we will have a special event that should be fun and less labor intensive than the *Salute*. In early October we will have a cocktail party to “unveil” the 2008 *Voters' Guide* and to which we will invite members, donors and those who distribute our publications. The party itself will not be intended to raise money, but there will be a raffle along with it. We are already working on collecting items for that raffle. This type of event should bring more attention to the *Voters' Guide* and to the League as well.

Our long-term goal is to put in place a fundraising campaign that can be built upon over the years. It is in the best interest of the League to do so. We hope it will be fun for our members, too.

The League of Women Voters, a nonpartisan political organization, encourages informed and active participation in government, works to increase understanding of major public policy issues, and influences public policy through education and advocacy.
