## Brian Sanderoff to speak at June General Meeting

Brian Sanderoff, president of Research and Polling Inc., will be the speaker at the June 9 General Meeting of the League of Women Voters of Central New Mexico. The meeting is at 11:45 a.m. at the MCM Elegante Hotel, 2020 Menaul NE.

One of his areas of expertise is demographic services and he will be working with the New Mexico Legislature to help redraw congressional and legislative districts for the state. The governor is expected to call a special session of the legislature in September for redistricting. At the meeting Sanderoff will talk about which areas have seen population growth and which areas of the state have lost population since the 2000 census.

This issue is of great interest to the league. The last two times the NM legislature drew districts after a census update the final result has ended in lawsuits. Redistricting is a responsibility of the New Mexico Legislature, not the courts. This redistricting session needs to have the public involved.

## Bernalillo Transparency Study

At the May Annual Meeting, the LWVCNM approved a Transparency Study for Bernalillo County. Interest in this study began in December 2010 at the Program Planning meeting. There was concern voiced about the unfolding problems in Bernalillo County, problems that ranged from ongoing problems at the Metropolitan Detention Center to the lack of transparency in the way decisions were made and money was handled in the county. Members who attended that meeting decided to pursue a transparency study to observe county government more closely.

Since that meeting the long-time county manager has resigned, the director of finance has retired and new county commissioner has taken

office. The new commission has passed a transparency ordinance, but many problems still remain.

This is a time of great transition in Bernalillo County as a new manager is hired and county government adjusts to the new commissioner.

One of the important things the league does is watch to assure that the processes of democracy work properly, that government administrators follow the rules, act in the best interest of the people they serve and operate in a way that allows genuine participation of the public.

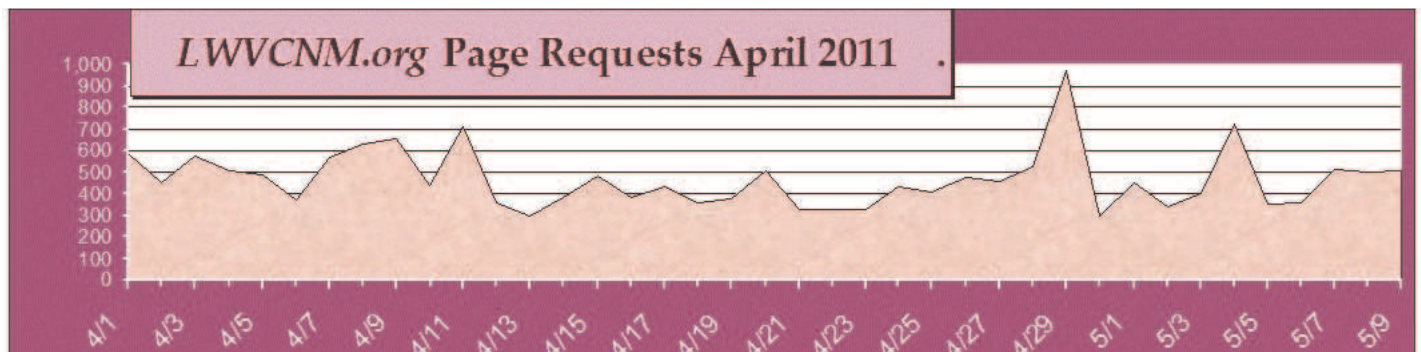


Donna Hill gives Andrea Targhetta a hug as Andrea Targhetta as she receives the Wall of Honor Award.

## More League Memories: Christina Little

*Editor's Note: These League memories of Christina Little are part of a series of reminiscences compiled for the Voter.*

William and I moved to Albuquerque in 1988, having joined the League in Harford County Md. and transferred to Austin, Texas.

I had already discovered that participating in the League was one of the very best ways of meeting interesting people in the community and becoming informed about civic affairs. It is also a place where members are given the opportunity to make valuable contributions to their communities. This was certainly true in Albuquerque! We were given plenty of challenges and met many extraordinary people who became friends as well as colleagues.

While in Albuquerque, I was privileged to work with six outstanding Local League presidents: Nancy Swigger, Alice Melberg, Carol Pierce, Shelly Shepherd, Sandra Browne and Marilyn Morgan. From Las Cruces, William and I provided support to Josephine Porter and Diane Goldfarb. We say we just "moved down the street" and have tried to stay reasonably well informed about the League of Women Voters of Central New Mexico and to show up at events when we could.

I had four significant roles with the League in Albuquerque – *Voter* and *Voters' Guide* editor, treasurer and president. For many years, I desktop published *The Voter*. This was in the days after mimeograph machines (glad these are gone) but in the relatively early days of desktop publishing. My mentor and teacher was Christine Stockman. She was a wiz and introduced me to the intricacies of desktop publishing in WordPerfect 5.1. "What you saw was not what you got," and I spent hours at Chris's house perfecting the first draft of each newsletter.

In all my experience with the Albuquerque League, the organization produced impressive *Voters' Guides*. There is a long tradition of out-

standing work. I got to witness the efforts of Pat Freeman and Louise Prowell continuing through Lois Kimbrell, Josephine Porter and Andrea Targhetta. I got to take my turn in 1996 as the editor of the General Election *Voters' Guide*. Our ability to produce such valuable Guides has been greatly enhanced by the active support provided by Don Anderson, owner of Ink Impressions which became Automated Election Services.

The local Education Fund was established while I was in Albuquerque. Developing the financial relationship between the regular League and the Education Fund was set up by Treasurer Bill Camp. He developed a spreadsheet that rigorously allowed the Ed Fund to pay its 'fair share' of operating expenses -- a big help to the ongoing fiscal health of the League. As someone comfortable with computers, I got to follow him in office. Following me, Harold Burnett set an especially high standard of service.

I was president of LWV/ABC from 1997 to 1999. The League was active in the community (supporting such initiatives as the Growth Management Plan) and enjoying robust volunteer support. There were several committees (Drug Policy, Education, Land Use Management, Transportation) and well-attended unit meetings. One of my greatest inspirations was asking JoAnne Ramponi to be the Membership Chair. What a winner that was! My favorite memory was the Salute to Albuquerque featuring old photographs of Albuquerque collected by Mo Palmer of the Albuquerque Museum and the music of the Watermelon Mountain Jug Band. Many of us dressed up and all had a blast. The most challenging time was an election that the League ran for the APS Educational Assistants. This seemed like a simple proposition, but the process was contested. Mary Wilson mediated the dispute in a most professional manner.
