Who Can Vote

You can vote, if you are a citizen of the United States, AND a resident of New Mexico, AND 18 years of age or older on Election Day, AND have registered to vote. Convicted felons who have satisfied all the terms and conditions of their sentencing are also eligible. You can register on the day you vote at most polling places.

How to Use This Voter Guide

Find out which districts you are in by either obtaining a sample ballot or contacting your County Clerk. (See instructions below.) Then use the *Voter Guide* Table of Contents to find the candidates, judicial retention races, and ballot issues that will be on your ballot. Both these steps can also be done online via nmVOTE.org or VOTE411.org!

Candidate responses and word limits. The responses of candidates to our questionnaires are printed exactly as entered by the candidate. The League assumes no responsibility for the content of any candidate's reply. Further, the League publishes this information neither to endorse nor reject the views of any candidates. The League has in no way edited for meaning, grammar, punctuation, or spelling. Because of space restrictions, the League has pre-advised the candidates of the word limits for the responses.

Sample Ballot and More

You can verify your voter registration online, view your sample ballot, apply for an absentee ballot and check its status, and much more at nmvote.org. Scroll down to "Find My Registration & Election Information."

You can also request a sample ballot from the County Clerk or at an early voting location in your county.

Registering to vote in New Mexico

As noted earlier, to register to vote you must be a U.S. citizen, a New Mexico resident, and at least 18 years old on election day. You will need to provide proof of your identity and residency. If you did not provide this information when you registered, then you will need to provide it the first time you vote.

Valid forms of proof include a current and valid photo identification, a current utility bill, bank statement, government check, paycheck, student identification card, identification issued by an Indian Nation, tribe, or pueblo that shows your name and current address, or other government document. To be sure, bring more than one of these credentials.

There are several methods and many places to register:

- nmvote.org. You can register using the nmvote.org portal if you have a valid New Mexico driver's license or identification card up until October 8, 2024.
- Via the Motor Vehicle Department and at organized voter registration drives until October 8.
- Mail-in registration. If you are registering for the first time in New Mexico, you must submit a copy of identification that shows both your name and your New Mexico address, or present these forms of identification the first time you vote.
- Same-day in-person voter registration. You can register in person at the County Clerk's office or at any Early
 Voting or Election Day location with your identification and proof of residency papers.

Changing/Updating Registration. No identification is required if a voter is merely changing their registration (name, address, and/or party affiliation) within the state of New Mexico.

Absentee Voting

New Mexico allows any registered voter to request an absentee ballot. You can request one at **nmvote.org**, or contact your County Clerk.

The last day to request an absentee ballot for the 2024 General Election is Tuesday, October 22.

Completed absentee ballots may be turned in at any polling place or Vote Center up through Election Day by 7:00 pm by the voter, a member of the voter's immediate family, or caretaker. You can also mail your ballot, but it must arrive by 7:00 pm on Election Day.

You can get on the permanent absentee list to receive an absentee ballot for every election via nmvote.org.

Additional Voting Considerations

<u>Write-in Voting</u>. Only some races will have this option. For these, you must write in the name of a qualified write-in candidate (these are listed in this *Voter Guide*). To count, you must enter the full name OR the first two initials and last name OR the first and last name OR first name, middle initial, last name, OR first name, middle name, and last name.

Provisional Ballots

You will be issued a provisional ballot if your name does not appear on the voter rolls, or you are a first-time voter but have not provided proof of identification and residency. The election officials will give you information on what you will need to do to ensure that your ballot will be counted and to see if it was counted.

Voting Offenses. These include

- Voting or trying to vote when not qualified
- · Voting in another person's name
- Voting more than once in a single election
- Asking someone to commit a voting offense
- Campaigning within 100 feet of a polling place
- Using or possessing alcoholic beverages within 200 feet of a polling place
- Unlawful possession of an absentee ballot
- Falsifying any information on an absentee ballot
- Intimidation
- Obstructing the polling place
- Disturbing the polling place

If you observe any of these offenses, you must report them to the County Clerk, District Attorney, or Secretary of State.

¿Quién puede votar?

Puede votar si es ciudadano de los Estados Unidos, es residente de Nuevo México, tiene 18 años o más el día de la elección Y se ha registrado para votar. También son elegibles los delincuentes convictos que hayan cumplido con todos los términos y condiciones de su sentencia. Puede registrarse el día que vota en la mayoría de los lugares de votación.

Cómo utilizar esta Guía para votantes

Averigüe en cual distrito vive por medio de obtener una boleta de muestra o comunicarse con el secretario de su condado (vea las instrucciones abajo). Luego, utilice la tabla de contenidos de la *Guía para votantes* para encontrar los candidatos, las carreras de retención judicial y los temas de votación que estarán en su boleta. ¡Puede hacer ambos pasos en línea a través de VOTE411.org!

Respuestas de los candidatos y límites de palabras. Las respuestas de los candidatos a nuestros cuestionarios se imprimen exactamente como las ingresó el candidato. La Liga no asume ninguna responsabilidad por el contenido de las respuestas de ningún candidato. Además, la Liga no publica esta información para aprobar ni rechazar las opiniones de ningún candidato. La Liga no ha editado ninguna respuesta con respeto a significado, gramática, puntuación, u ortografía. Debido a las restricciones de espacio, la Liga ha informado previamente a los candidatos sobre los límites de palabras de las respuestas.

Boleta de muestra y más

Puede verificar su registro de votante en línea, ver su boleta de muestra, solicitar una boleta de voto en ausencia y verificar su estado, y mucho más en **nmvote.org**. Desplácese hacia abajo hasta "Buscar mi registro e información electoral".

También puede solicitar una boleta de muestra del secretario del condado o en un lugar de votación anticipada en su condado.

Registrarse para votar en Nuevo México

Como se indicó anteriormente, para registrarse para votar debe ser ciudadano de los EE. UU., residente de Nuevo México y tener al menos 18 años el día de las elecciones. Tendrá que proporcionar una prueba de su identidad y residencia. Si no proporcionó esta información cuando se registró, deberá proporcionarla la primera vez que vote. Las formas válidas de prueba incluyen una identificación con fotografía actual y válida, una factura de servicios actual, un estado de cuenta bancario, un cheque del gobierno, un talón de pago, una tarjeta de identificación de estudiante, una identificación emitida por una nación, tribu o pueblo indígena que muestre su nombre y dirección actual, u otro documento gubernamental. Para estar seguro, lleve más de una de estas credenciales. Hay varios métodos y muchos lugares para registrarse:

- nmvote.org. Hasta del 8 de octubre de 2024, puede registrarse usando el portal en nmvote.org si tiene una licencia de conducir o una tarjeta de identificación de Nuevo México válida.
- A través del Departamento de Vehículos Motorizados y en campañas de registro de votantes hasta el 8 de octubre.
- Registro por correo. Si se está registrando por primera vez en Nuevo México, debe presentar una copia de una identificación que muestre tanto su nombre como su dirección en Nuevo México, o presentar estas formas de identificación la primera vez que vote.
- Registro de votante en persona en el mismo día. Puede registrarse en persona en la oficina del secretario del condado o en cualquier lugar de votación anticipada o el día de las elecciones con su identificación y documentos que prueben su residencia.

Cambio/Actualización de Registro. No se requiere identificación si un votante simplemente cambia su registro (nombre, dirección, y/o afiliación partidista) dentro del estado de Nuevo México.

Voto en ausencia

Nuevo México permite que cualquier votante registrado solicite una boleta de voto en ausencia. Puede solicitar una en **nmvote.org** o comunicarse con el secretario de su condado.

El último día para solicitar una boleta de voto en ausencia para las elecciones generales de 2024 es el martes 22 de octubre.

El votante, un miembro de la familia inmediata del votante o un cuidador pueden entregar los votos en ausencia completados en cualquier lugar de votación o centro de votación hasta el día de las elecciones antes de las 7:00 de la tarde. También puede enviar su boleta por correo, pero debe *llegar* antes de las 7:00 de la tarde el día de las elecciones.

Puede inscribirse en la lista permanente de votantes ausentes para recibir una boleta de voto en ausencia para cada elección a través de **nmvote.org.**

Consideraciones adicionales de votación

<u>Votación por escrito.</u> Sólo algunas carreras tendrán esta opción. Para estas, debe escribir el nombre de un candidato por escrito que es calificado (estos se enumeran en esta Guía para votantes). Para que su voto cuente, debe ingresar el nombre completo O las dos primeras iniciales y el apellido O el nombre y apellido O el nombre, la inicial del segundo nombre, el apellido, O el nombre, el segundo nombre, y el apellido.

Boletas Provisionales

Se le emitirá una boleta provisional si su nombre no aparece en las listas de votantes, o si está votando por primera vez pero no ha proporcionado prueba de identificación y residencia. Los funcionarios electorales le darán información sobre lo que deberá hacer para asegurarse de que su boleta sea contada y para ver si fue contada.

Delitos de voto. Estos incluyen

- Votar o intentar votar sin estar habilitado
- Votar en nombre de otra persona
- Votar más de una vez en una sola elección
- Pedirle a alguien que cometa un delito de votación

 Llegar compaña a manage de 100 pira de un lugar de unterpresentation.
- Hacer campaña a menos de 100 pies de un lugar de votación
- Consumir o poseer bebidas alcohólicas a menos de 200 pies de un lugar de votación
- Posesión ilegal de una boleta de voto en ausencia
- Falsificar cualquier información en una boleta de voto en ausencia
- Intimidación
- Obstruir el lugar de votación
- Alterar el lugar de votación

Si observa cualquiera de estos delitos, debe denunciarlos al secretario del condado, al Fiscal de Distrito o al secretario de estado.

WHERE AND WHEN TO VOTE / DÓNDE Y CUÁNDO VOTAR

November 5 from 7am to 7pm. This is also the deadline for turning in absentee ballots at one of the Election Day voting locations or the County Clerk's office.

Early voting times and dates vary by county. Election Day voting will be Los horarios y las fechas de votación anticipada varían según el condado. In the 2024 Session I passed the Healthcare Consolidation Oversight Act, and am spending the interim working with stakeholders -- the Supt. of Insurance, medical providers, patients and patient advocates -- to evolve this essential oversight that New Mexico has lacked until now. Voting rights, education, public safety, and addressing climate change are also priorities of mine.

Water is a sacred resource, and I am very concerned about the projections I am hearing about water availability in the not so distant future. We should be working with climate scientists to take action now, should be incentivizing agriculture that does not use large amounts of water, and need to continue guarding against policies that prioritize profitability over sustainability.

We need to address root causes of crime like poverty, and substance abuse, but we also can't wait 20 years for results. In the mean time, we need to invest in evidence-based approaches -- not window dressing. Too many of the "solutions" that are pushed these days are things that data shows do not actually change behavior. When we waste our time on things that are not effective, that takes critical funds and energy away from approaches that can actually make a difference.

One 2016 study by UNM revealed that for every \$1 our City invests in housing someone, we earn back \$1.78. Plus, once housed, almost 90% stay housed for more than a year. The smartest way to solve homelessness is housing through voucher programs or by building more affordable housing.

I would ask groups like ABCWUA and the Middle Rio Grande Water protection groups to lead on real actionable plans that directly relate to their communities. Additionally, our state agencies, such as the Office of the State Engineer and Interstate Stream Commission, need resources to get their jobs done—including updated technology to collect the right data. Long-standing challenges require multi-pronged, coordinated policy initiatives. The legislature is addressing the provider shortage, but more needs to be done. Implementing measures that include: student loan forgiveness programs that encourage providers to locate in areas with the most need; expanded tax credits for critically needed providers; expanded educational programs to increase the number of New Mexicans training for all medical professions. Incentive and retention strategies are key.

Improve Extreme Risk Protection Order law and train police on its effective use. Enact other gun safety laws shown to reduce gun violence. Prioritize incarceration of the truly dangerous and implement alternate sentencing and diversion programs that provide drug and behavioral health treatment, and job training. Focus on programs that are evidence-based and data driven. The data and evidence have shown us that the so-called tough on crime proposals fail us time and time again.

Enact laws that regulate and minimize access to and use of excessively large quantities of fresh water by industrial users by encouraging alternatives. This could include desalination initiatives and produced water reuse in the oil fields. Complete an assessment of water availability and implement regional water plans that address water use on a regional basis and tied to the conditions relevant to the area. The state is acting on inadequate data which hampers its ability to plan effectively.

Poverty is the underlying cause of nearly every challenge facing New Mexico and its citizens. The legislature is addressing it through an array of efforts that include increasing support for low income families, Pre-K, early childhood and child care programs. Those cases that involve non-violent crimes stemming from drug addiction, we try to divert into treatment programs. In 2023, we diverted over 2,500 people into treatment programs; most in the history of the office. For violent criminals – since becoming District Attorney – the pretrial detention rate in Bernalillo County has increased by 10%, keeping more violent offenders in jail.

In the 16 months that I have been District Attorney, my office has hired over 50 attorneys, who come from both in and out of state. Our tactics to attract attorneys who are best-suited for our office include providing incentives, competitive salary, regular employee appreciation, and providing extensive trial experience. Attorneys who begin a career at my office receive one-on-one training that is strategic and unmatched, compared to any other training for new attorneys in the state.

As an appellate judge, I have resolved hundreds of appeals in all areas of the law and assisted with Court administration. I previously was a trial judge in Northern New Mexico where I managed a varied docket, presided over thousands of cases, and held over 50 trials. Prior to joining the bench, I served as an appellate attorney and litigator in a variety of civil and criminal cases and clerked for a federal trial judge.

The Court of Appeals is responsible for resolving the vast majority of appeals in New Mexico and, as a result, has a busy and heavy docket. The Court has made significant progress in resolving cases more quickly. Through the tireless efforts of staff and judges, the Court has cleared its backlog that had previously been amassed due to judicial turnover. The Court is dedicated to building on this progress and has adopted programs to increase efficiencies. The Court piloted a program that streamlines the appeal process, and recently implemented a program that provides free mediation services to more expeditiously resolve appeals. We are working to expand these programs and continue to explore other ways to better serve New Mexicans.

The Court of Appeals is focused on expanding public access and improving Court administration. During the pandemic, the Court began allowing unrepresented parties to electronically file court documents; and we are working to expand electronic access for unrepresented parties. The Court will be publishing self-help materials that explain the appellate process and assist unrepresented parties and attorneys in meeting their obligations on appeal. We will be rolling out live-streaming to increase access to our proceedings. The Court of Appeals also is working to obtain needed funding to build its administrative team, so the Court is more efficiently and effectively run. The current lack of staffing greatly overburdens our staff and judges.

I have been a judge on the NM Court of Appeals since my appointment by the Governor in 2020. In that time, I have gained valuable experience as an appellate judge. Prior to becoming a judge, I had a diverse career practicing in both criminal and civil law. I practiced in both state and federal court at the trial and appellate level. I have dedicated my career to ensuring diversity and equity in the judicial system.

We have worked hard the last several years to reduce the time it takes for us to rule on cases before our court. We currently have two pilot projects that have dramatically decreased the time to file opinions in our cases. One impacts our criminal cases, and we have seen our turnaround time dramatically improve. The other is our mediation program, which while new, has already helped with our civil cases. I am dedicated to continuing our efforts to reduce our caseload and find ways to ensure we are ruling on cases in a timely manner.

The main issue that our court has faced is a lack of resources. It has been a priority of mine to ensure that we have more resources. We have used these resources to rebuild our administrative staff and building maintenance. Our priority as judges should be to focus on our cases and to do so, we need the proper resources to ensure our court functions at the level expected by the parties who appear before us. We still have some improvements to make, but we have done a lot to rebuild the past several years.

Judge of the Court of Appeals-Position 3

I have served as a judge on the Court of Appeals for nearly six years now and gained tremendous experience from working on hundreds of cases involving a broad range of legal issues. I take care with every case to show the parties that we have fully and fairly considered the issues, and to impartially explain what the law says about the issue so the parties understand our decision. Before joining the Court, I had 10 years of experience as an attorney. I began my legal career as a law clerk of Justice Richard Bosson at the New Mexico Supreme Court.

The Court of Appeals experienced tremendous judicial turnover from 2015-2022, which resulted in a backlog of hundreds of cases. My colleagues and I have worked hard for several years to clear that backlog and I'm happy to report that we have done so. Stability on the Court (no turnover in the last 2 years), was important to accomplishing this goal. In addition, we received some additional resources from the Legislature in the last few years, which allowed the Court to restart a mediation program, fill vacant positions, and work with retired appellate judges on a pro tem basis. That was a wonderful experience, and having a robust pro tem program could benefit courts, especially during periods of turnover.

While we are proud of our work in clearing the backlog, the Court still wants to move cases faster through the court. We have set a goal of resolving 95% of all cases within 720 days, or just under two years. We have made tremendous progress in our time-to-disposition, but still have work to do. We have been working to obtain the resources we need (both funding and personnel), and piloting programs that we hope will allow us to resolve cases quicker, including (1) a revamped mediation program, (2) a pilot project for criminal cases that produces briefing earlier in the case, and (3) a speech-to-text program that allows us to review trials and hearings more efficiently.

Judges need the support of the legislature to fund substance use and mental health programs for defendants who need these services. These services are critical for defendants in the justice system and will ultimately improve the health and safety of the community. Training in substance use disorders will continue to aid judges in understanding addiction issues and result in appropriate sentencing where possible.

The Court should focus on returning to in-person hearings for many cases because the public continues to have difficulty appearing virtually, which is very difficult for court staff to manage while also handling in-person duties. Competitive wages for court staff is also important to keep well-trained individuals working for the court and to attract individuals to fill vacant positions.

NEW MEXICO CONSTITUTIONAL AMENDMENTS

Constitutional Amendment No. 1

"Proposing an amendment to Article 8, Section 15 of the Constitution of New Mexico to extend a property tax exemption, currently only allowed for one hundred percent disabled veterans and their widows and widowers, to veterans with less than a one hundred percent disability and their widows and widowers and basing the amount of the exemption on a veteran's disability rating."

Analysis is based on current information. Constitutional amendments No. 1 and No. 2 both relate to property tax reductions for veterans and their spouses. These amendments are additive. For instance, if both amendments pass, the effect on households in Bernalillo County that are not eligible would be a recurring property tax increase of \$50 – \$100.

Residential property taxes are used to pay a large part of the expenses of New Mexico's schools, public health facilities, and local governments.

The NM Legislative Finance Council's "rough conclusion" in 2023 was that the new exemption would create an annual average property tax reduction of \$767. These savings would be in addition to the standard veteran property tax exemption of \$4,000 available to all veterans who own residential property.

The NM Taxation and Revenue Department has concluded that the new exemption "would represent a significant erosion of the local property tax base, on which most local governments rely for their budgets and operations." It estimates that \$27.2 million in 2026 and \$29.2 million in 2027 will be shifted to non-qualifying property owners.

The proposed amendment also requires an automatic increase in residential property taxes for those not eligible for the new exemption to make up approximately 40 per cent of the revenue lost due to the new exemption. The language of the amendment does not require non-residential or commercial business property owners to pay additional taxes to make up any of the difference.

Local government bodies and schools would bear most of the loss of revenue from passage of the amendment, and the LWVCNM has not located any description of how or when the shortfall in revenue might be recovered by government entities.

ARGUMENTS FOR THE AMENDMENT

- The exemption is intended to provide disabled veterans protection from rising property taxes. Allowing the
 property tax exemption for veterans with a permanent service-connected disability will support property-owning disabled veterans and their widowed spouses in an amount proportional to the percentage of the
 veteran's disability rating.
- 2. The new property tax exemption sends the message that anyone who suffers a disability while serving in the armed forces deserves to be taken care of equitably, regardless of the severity of the injury.
- 3. The amendment is intended to express the support of the state for veterans.
- 4. The amendment assumes a decrease in property tax could provide an incentive for veterans of the armed forces to move to and buy property in New Mexico, which might increase the state's population and tax base.
- The amendment assumes the estimated cost of an additional annual per capita tax burden for the general population of the state is low compared to the benefit provided for the service-related disabled veterans with property tax liability.

ARGUMENTS AGAINST THE AMENDMENT

- 1. The new exemption could be seen as disproportionately benefiting those who do not need financial assistance. If the purpose is to relieve the financial burden on those who are unable to pay property taxes due to their disability, then the exemption should target those with limited incomes.
- Financial assistance is already available for disabled veterans through a number of programs. Numerous state, federal and nonprofit programs serve veterans, including programs to assist disabled veterans with living expenses.
- Non-disabled-veteran property taxpayers, including seniors and persons who have a non-service related disability, will pay more due to the new exemption.
- 4. A property tax is traditionally based on the value and nature of the property, not the personal characteristics of the owner. Creating an exemption for certain individuals would be a departure from the underlying principles of property taxation and could set a precedent for other groups to seek a similar exemption.
- The federal government should help disabled veterans, not the state. If voters believe that more compensation is due to disabled veterans and their spouses, then they should ask their representatives in Congress to address the issue.
- 6. Property tax benefits for veterans already exist in the Constitution of New Mexico. There is a \$4,000 exemption for all honorably discharged veterans.
- 7. The exemption excludes other property taxpayers who are disabled due to work-related injuries. There are many dangerous but necessary occupations with a high chance of disability from injury, so it is unclear why disabled veterans warrant preferable treatment in comparison to other disabled persons.

Constitutional Amendment No. 2

"Proposing an amendment to Article 8, Section 5 of the constitution of New Mexico to increase a property tax exem
tion for honorably discharged members of the armed forces and their widows and widowers."

Analysis: Constitutional amendments No. 1 and No. 2 are additive. For instance, if both amendments pass, the effect on households in Bernalillo County that are not eligible would be a recurring property tax increase of \$50 - \$100.

Residential property taxes are used to pay a large part of the expenses of New Mexico's schools, public health facilities, and local governments.

This amendment would increase the property tax exemption for honorably discharged veterans and their surviving spouses from the current amount of \$4,000 to \$10,000 a year. This amount would be adjusted annually for inflation, although the amendment does not specify the mechanism for that adjustment. If the amendment is approved, it would require additional legislation to become effective.

Local government budgets will bear most of the loss of revenue from passage of this amendment, and the LWVCNM has not located any description of how or when the loss in revenue resulting from passage of the amendment might be recovered by government entities.

The Legislative Finance Committee also concluded in 2023, that "[I]ocal impacts of the legislation proposed in this bill will vary widely across the state depending on the local trends in property values, the per capita population of veterans in the county, as well as the remaining local authority to adjust property tax rates," and "the effect of change would also be highly variable depending on the city, county, and school district property tax rates in effect at the location of the veteran's principal residence..."

ARGUMENTS FOR THE AMENDMENT

- This amendment is intended to support property-owning veterans and their widows or widowers and might help them maintain homeownership by reducing the amount of property tax paid by honorably discharged members of the armed forces and their widowed spouses. This exemption, however, is not specific to owneroccupied primary residential property.
- 2. This amendment is intended to express the support of the state for veterans.
- 3. The amendment assumes a decrease in property tax could provide an incentive for veterans of the armed forces to move to or buy property in New Mexico, which may increase the state's population and tax base.
- 4. The amendment assumes that by adjusting the amount of the exemption for inflation, the amount of the exemption for veterans will increase without requiring a future constitutional amendment, which is a challenging, lengthy and costly process.
- 5. The amendment assumes the increased exemption amount is fairer to veterans and their spouses. The current exemption was set in 2002 and, since then, the value of the dollar has increased approximately 72% while property values have increased by approximately 80%.

ARGUMENTS AGAINST THE AMENDMENT

- Congress should be responsible for providing veterans' benefits. It is inappropriate for homeowners and other
 residential property owners and local governments to bear the expense of providing extended benefits to
 veterans in return for their service in a branch of the United States armed forces. If more generous benefits
 are due to veterans and their spouses, Congress should provide those benefits.
- The increased exemption could benefit those who chose to enlist. The mandatory United States military draft
 ended in 1973, and the military has been an all-volunteer force for more than 50 years. Special property tax
 benefits should not be extended to someone who makes the choice to work in a branch of the United States
 armed forces.
- The increased exemption could be seen as unfair to other property taxpayers who will pay more property taxes due to passage of the amendment.
- 4. Traditionally, most tax relief measures are based on need. There is no evidence that veterans have lower incomes or a greater need for property tax relief than other taxpayers. It is possible that, with the passage of the proposed constitutional amendment, veterans who are financially stable and who own large, high-value homes will be relieved from contributing their fair property tax share.
- 5. Exemptions for special groups of property taxpayers could set a precedent for other individuals to seek tax relief. Traditionally, property tax is based on the value and nature of the property, not the personal characteristics of the owner. Creating an exemption for certain individuals is a departure from the underlying principle of property taxation and could set a precedent for other groups to seek similar exemptions.
- The exemption amount only benefits a portion of veterans, since it applies only to veterans who are residential property owners and excludes veterans who are renters.
- 7. The inflation provision in the amendment would increase property taxes even more for non-veteran property taxpayers. The proposal to index the amount of exemption for inflation may continue to erode the property tax base and annually increase the property tax bills for those who are not eligible for the property tax exemption.

"Proposing to amend Article 6, Section 35 of the Constitution of New Mexico by allowing the dean of the University of New Mexico school of law to appoint a designee to the Judicial Nominating Commission."

ARGUMENTS FOR THE AMENDMENT

- 1. The role of chair of the Appellate Judges Nominating Commission is primarily administrative. These are not tasks that require the legal mind of the dean of a school of law, but even if they were, this proposed amendment ensures that there will be an esteemed legal scholar serving as chair of the commission. The Rules Governing Judicial Nominating Commissions outline the role of the chair and task the chair with the duties of announcing the existence of a judicial vacancy to the public and members of the commission, scheduling meetings of the commission and providing the media with notice of the meetings, preparing application packets and preparing agendas for meetings.
- 2. The University of New Mexico School of Law serves a vital interest to the state by educating a vast majority of the attorneys who practice here since it is the only school of law in New Mexico. Beyond the normal duties of being the dean of a school of law, and the current requirement to serve as chair of the Appellate Judges Nominating Commission, the dean is also required by statute to serve as the chair of the Judicial Compensation Commission. Allowing the dean's designee to serve on the Appellate Judges Nominating Commission would relieve the dean of a commitment that could be performed by others
- 3. The dean of the University of New Mexico School of Law is already permitted to have a designee for important commissions, including the New Mexico Sentencing Commission and the New Mexico Compilation Commission. The dean is also required to appoint three members to the Public Defender Commission. Each of these commissions has functioned adequately without requiring the dean to attend every meeting. The dean should be allowed to appoint a designee

ARGUMENTS AGAINST THE AMENDMENT

- 1. The amendment potentially removes a neutral tie-breaking vote from the commission. When the Appellate Judges Nominating Commission was created, there was a desire to have a neutral person who could break any of the commission's tie votes. The legislature, which passed the joint resolution to create the commission, and the people, who voted to pass the constitutional amendment in 1988, believed that the dean of the University of New Mexico School of Law was the best person to put into this neutral tie-breaking role.
- 2. The amendment could remove one of New Mexico's most prominent legal scholars from the judicial appointment process. The Appellate Judges Nominating Commission serves a vital role in New Mexico's judicial system by vetting and nominating candidates for the most prominent judicial positions in the state. The dean is tapped into New Mexico's legal community by virtue of being the head of the state's only law school. The dean's connections in the legal community could provide insight into the careers and backgrounds of the applicants that the commission vets.

Constitutional Amendment No. 4

"Proposing an amendment to Article 10, Section 1 of the Constitution of New Mexico to provide that the salaries of county officers shall be established by the Board of County Commissioners, remove references to the first legislative session and clarify that any fees collected by a county official shall be paid into the treasury of the county."

ARGUMENTS FOR THE AMENDMENT

- 1. While it made sense for the legislature to set county officer salaries when the state was new, the counties are now longstanding, established entities that handle their own affairs without such close state guidance. This amendment is a measure to modernize the system to better reflect the realities of day-to-day governance. The current law only sets maximum salaries for county officers and already allows boards of county commissioners discretion in determining salary increases for their officers within the statutory limitations.
- 2. County officers manage complex bureaucracies and require executive experience and specialized skills to be effective on behalf of their constituents. To ensure that voters have the opportunity to elect qualified officers, counties need the flexibility to set salaries to attract experienced and skilled candidates. This amendment would allow counties to be more responsive to their own needs and provide for more professional management.
- 3. Constitutional and statutory safeguards exist to check the power of county commissioners in setting salaries. The constitution and laws of the state have measures that serve as a check on the powers of county commissioners in setting the salaries of county officers.
- 4. This amendment will give voters more say in how their counties are managed. County officers are locally elected and directly accountable to their constituents. This amendment would localize salary decisions and make county officers more accountable to their constituents.

ARGUMENTS AGAINST THE AMENDMENT

- 1. Without legislative oversight, county official salaries will be wide-ranging and inconsistent across counties. Pursuant to its current obligation to fix the salaries for county officers, the legislature has established a comprehensive classification system based on a combination of a county's population and the total value of real estate within the county. This system helps to ensure that salaries are uniform and proportional across the state. This proposed amendment empowers boards of county commissioners to establish officer salaries without any standards.
- 2. Removing the legislature's authority could lead to negative consequences for counties. Allowing boards of county commissioners full discretion to determine salaries for their officers takes authority and power away from the legislature. The people of the state have an interest in the legislature retaining the power to set county officer salaries because it serves as a mutual check, is a reasonable limit on counties' powers and requires accountability from the legislature.
- 3. County commissioners would set their own salaries. Currently, Article 10, Section 1 of the Constitution of New Mexico places the legislature in a neutral third-party role and provides assurances to the people of the state that county officer salaries are determined impartially. This proposed amendment may make these determinations more susceptible to short-term political or personal considerations.

GENERAL OBLIGATION BOND QUESTIONS

A bond represents money borrowed by a government to finance capital improvement projects. The bonds are called general obligation (GO) bonds because payment of the debt (principal plus interest) is a general obligation of the governmental entity issuing the bond.

GO bonds are sold to bond investors, subject to voter approval of separate bond questions, as a way to generate revenue for capital projects. GO bonds must be sold within a specific time after voter approval. They must be fully spent on capital (bricks and mortar) projects or equipment, not on daily operations or maintenance. Bond money cannot be transferred from one category to another.

BERNALILLO COUNTY

Bernalillo County will ask voters to authorize the issuance of GO Bonds for the 2024 bond cycle (years 2025-2026) totaling \$40,500,000. The projects have been grouped according to their general purposes into six ballot questions.

There are separate bond questions on the ballot for roads, drainage, utilities, buildings, public safety, community facilities, and libraries. This allows voters to have the option to approve one purpose and not another. A detailed listing of the projects proposed for these bond issues can be viewed at lwvcnm.org and on the Bernalillo County website. Passage of the bond issues will not increase property tax rates.

Bond Question 1 - Library Bonds

CITY OF ALBUQUERQUE CHARTER AMENDMENTS

PROPOSING TO AMEND THE ALBUQUERQUE CITY CHARTER REGARDING THE PROCEDURES FOR APPOINTMENT OF ADMINISTRATIVE OFFICERS AND APPOINTMENT AND REMOVAL OF THE CHIEF OF POLICE AND FIRE CHIEF

Analysis:

The proposed amendment changes the Albuquerque City Charter to modify the procedures to appoint city administrative officers. City administrative officers are defined as any position with supervisory authority over anyone in a department director position. The proposed amendment would require the mayor to reappoint, and the council to approve all city administrative officers, the Chief of Police and the Fire chief at the beginning of each new term. It limits the time city administrative officers may serve without council approval. It would also allow the council to terminate employment agreements of the Chief of Police and the Fire Chief with a two-thirds plus one of the membership of the council.

Arguments for the proposed amendment:

- 1. Intended to provide greater collaboration between the mayor and the council.
- 2. Intended to provide more checks and balances for these positions of great importance for the entire citizenry through their elected council representatives.
- Limits the amount of time the mayor can employ interim administrative officers without council approval.

Arguments against the proposed amendment:

- Council may terminate the police or fire chief at any time within the terms of the employment contract without giving a reason by a vote of seven councilors.
- 2. Effect of passage of the amendment would give police and fire chief uncertainty as to who to look towards for leadership amongst a number of people who may have differing priorities.
- 3. May be difficult to find qualified applicants to accept position with such conditions.

PROPOSING TO AMEND THE ALBUQUERQUE CITY CHARTER REGARDING THE PROCEDURE TO DETERMINE SEPARATION OF POWER ISSUES UNDER THE CITY CHARTER

Shall the City of Albuquerque Charter be amended to modify the procedures for determination of separation of powers issues under the city charter?

Analysis:

This proposed amendment attempts to clarify the procedure used by the city to resolve differences between the mayor and the council. The current charter establishes a committee of three with one appointment by the mayor, one by the council, and a third member chosen by the two appointees. If either the mayor or the council fails to make an appointment, as has happened in the past, then the negotiation process is stalled. This amendment requires that these committee members by appointed within 60 days and effectively would allow either the mayor or the council to appoint all three committee members if one of the parties fails to make a committee appointment within the set time.

Arguments for the proposed amendment:

- 1. It is designed to assign responsibility for tracking committee appointments to the city clerk.
- 2. It should prevent a delay in filling a vacancy from impeding the work of the conference committee.
- 3. It is meant to provide an incentive for filling conference committee vacancies in a timely manner.

Arguments against the proposed amendment:

- 1. Allowing 60 days for appointments to the conference committee is helpful because it sets a deadline, but may be too long for the committee to work effectively.
- 2. The proposed amendment does not provide an option in the event that the council is unable to agree on a replacement other than allowing the mayor to fill two positions.




